## **Key Talking Points: Section 1709 Audit**

- My name is [NAME], and I live in [CITY OR ZIP CODE]. I am asking you to make sure that a
  national security agency like the Department of Homeland Security carries out a review of DJI
  and Autel drones by December.
- Share your personal reasons for caring about this issue, how you use drones for your business, hobby, public safety or research. Specifics are always helpful, such as information about specific projects you have worked on, successful missions, how many people you employ/how you support your community, etc.
- Congress passed a law last year, the NDAA, that required this review take place, so asking that it be completed quickly is just asking them to finish what they have already been directed to do.
- This is important because if the security review is not done in time, it would prevent DJI and Autel, two of the leading drone manufacturers, from bringing new products to the U.S. market and could possibly ground the drones people already own too.
- Restrictions like these would harm public safety, business, research and even hurt those who
  just fly drones for fun in our community by leading to rising costs and product shortages for all
  users.
- Share what it would mean for you how a ban on DJI or Autel products would impact your business, hobby, public safety or research.
- Beyond just me personally, for public safety efforts, it would put even lives on the line as many agencies have built successful drone programs with DJI or Autel drones.
- According to one study, 67% of small businesses that use drones would be forced to close if they could no longer use them.
- The study also found that hundreds of thousands of Americans across the country would lose their jobs, hurting the American economy.
- If you take any personal security precautions with your drone, such as flying in Local Data Mode, clearing your data regularly, etc., make sure to mention those abilities.
- Before you leave, thank them for their time and remind them to ask DHS or another national security agency to conduct the audit!

## **Key Talking Points: Customs Delays**

• My name is [NAME], and I live in [CITY OR ZIP CODE]. I wanted to bring to your attention some delays that are leading to delays, shortages and stock issues for many drone users.

- Share your personal reasons for caring about this issue, how you use drones for your business, hobby, public safety or research. - Unfortunately, reports show that shipments of DJI drones are being delayed by Customs. There
  is no reason given for these delays but they seem to be widespread, meaning that people who
  have already bought drones are waiting weeks and months with no answer as their drones sit at
  Customs.
- This has also led to drone shortages and supply issues, which is a major problem for those who
  use drones for public safety, search and rescue, business, research, and even those flying for
  fun.
- DJI drones make up the majority of these drones in use today, and other drone options to replace them are either limited or do not even exist.
- Share what it has meant for you if you are a dealer who cannot keep items in stock, a drone user who cannot purchase a new platform, or just someone who wants to purchase the latest product line and has not been able to.
- We deserve answers. Please pass along my concerns to U.S. Customs and Border Protection and ask for clarity for me and your other constituents that use drones.
- Before you leave, thank them for their time and remind them to ask Customs for more information about this situation!
